GUIDE INTRODUCTION



This currency guide provides detailed requirements including any additional banking information that is necessary for the payment of local currency.

STANDARD REQUIREMENTS FOR ALL INTERNATIONAL PAYMENTS

Standard Requirements

The information listed above is mandatory for every transfer and should be provided along with any additional requirements for every transfer in all STONEX currencies. Without it, STONEX will be unable to process the concerned payment.

STONEX also recommends that full remitting chain details are disclosed in any payment instructions.

Purpose of Payment

The purpose of the EU Wire Transfer Regulations* is to promote transparency and traceability within wire transfers to reduce the risks of money laundering and terrorist financing. Accordingly, STONEX requires its customers to provide a purpose of payment for each and every transaction. Without a meaningful purpose of payment, transfers risk being stopped or rejected.

*REGULATION (EU) 2015/847 on information accompanying transfers of funds and repealing Regulation (EC) No 1781/2006.

Special Formatting / Additional Banking Information

This field will outline any additional information that is required to process the transfers via the relevant onshore payment system. This will be in addition to STONEX's standard requirements.

Capital Injections

If a capital payment of any description (loan services, capital injection, investment, etc.) or any type of payment that may result in a future repatriation is required, please contact your STONEX representative before execution of the transaction. Local regulations may require completion of additional documentation and not all payment types can necessarily be supported.

PSD2 Regulations

Please note that shared charges may be applied for payments in the EEA, subject to PSD2 regulations. This may result in deductions to the amount received by the beneficiary.

Supporting Documentation

Beneficiaries may be required to provide supporting documentation to comply with the relevant jurisdiction's Exchange Control Regulations. This is true of any of STONEX's currency offerings, whilst the request for supporting documentation can come from any bank involved in the remitting chain of the concerned transaction.

Requested MT103

For each available currency, STONEX has provided example payment instructions containing specific formatting according to the currency requirements in question. Each requested MT103 has been formulated in collaboration with our local onshore partners and is based on information from the relevant jurisdictions' local payment system. As such, each example MT103 meets onshore requirements; adhering to the requested formatting will ensure that any payments do not fail in the relevant local clearing system.

Prohibited Transactions

STONEX does not support transactions for or related to any of the following industries; Shell Banks, Arms, Defense and Military Organizations, Atomic Power, Unregulated Charities, Adult Entertainment, Virtual Currencies, Marijuana and Gambling.

Salary and Wage payments are permitted for CNY payments

Full beneficiary address must be included in Field 59.

AED: United Arab Emirates Dirham

Full beneficiary address must be included in Field 59.

KRW: South Korean Won

The government-issued national ID for individuals and the residence permit number for foreign national residents is no longer mandatory, however, it may be requested by the onshore bank on an ad-hoc basis.

CURRENCY UPDATES



24th FEBRUARY 2022

UAH: Ukrainian Hryvnia

Following Russia's military action into Ukraine, the Ukrainian Central Bank have announced they are suspending their FX Market. As such, StoneX are suspending all Ukrainian Hryvnian (UAH) transactions until further notice.

24th FEBRUARY 2022

RUB: Russian Ruble

StoneX have taken the pre-emptive decision to suspend the currency and processing any payments into Russia until further notice.

24th FEBRUARY 2022

BYN: Belarusian Ruble

StoneX has suspended trading in BYN following Russia's military action into Ukraine and in anticipation of sanctions against Belarus.

4th MARCH 2022

BIF: Burundian Franc

Beneficiary account number must be in an 11-digit format.

31ST MARCH 2022

CNH: Chinese OFFSHORE (Renminbi)

The Purpose of Payment code is not required for offshore payments.

31ST MARCH 2022

CAD: Canadian Dollar:

Postal Box or P.O. Box or P.O. number is not accepted as the beneficiary's street address

9th June 2022

MZN: Mozambican Metical

Full beneficiary street address is required in field 59

16th June 2022

GYD: Guyanese Dollar

Funds paid to the Guyana Revenue Authority requires a reference with the following format: YY/MM/DD/RRRRRRRRRR. The relevant reference can be obtained from the Guyana Revenue Authority.

17th June 2022

LBP: Lebanese Pound

New underlying remitters and beneficiaries no longer require pre-approval by StoneX correspondent bank.

27th June 2022

MRU: Mauritanian Ouguiya

Payments toward the fishing and mining industries, and payments related to exports must be made in hard currency.

5th July 2022

THB: Thai Bhat

Clear and detailed purpose of payment description and code will be mandatory for all payments. Purpose code to be provided under format /POP/XXXXXX/ with XXXXXX denoting the relevant purpose of payment code in Field 70 or Field 72. Grace period provided to adhere to this requirement is until 31 Dec 2022. Supporting documents are no longer mandatory, but they can still be requested on an ad-hoc basis.

14th July 2022

AZN: Azerbaijanl Manat

Tax payments to the State Treasury Agency (CTREAZ22) a Budget Level Code (1 numerical-digit) and a Classification Code (6 numerical-digits) are required.

14th July 2022

SLL - SLE: Sierra Leone

Sierra Leone has a new currency: the New Sierra Leonean Leone (SLE). SLE will replace SLL.

15th July 2022

BRL: Brazilian Real

StoneX is unable to support payments to beneficiaries who hold an account with Ourinvest Bank, Maxima Bank, Travelex, Topazio Bank, Confidence Bank and Bex Bank.

27th July 2022

DZD – Algerian Dinar

Any payment flows to individual beneficiaries (B2P and P2P) must be pre-approved onshore before the trade is booked. Please contact your StoneX representative in advance to discuss your requirements.





5th August 2022

KHR: Cambodian Riel

Tax payments in favour of the General Department of Taxation (GDT) can be supported. Please reach out to your StoneX representative for information regarding the required supporting documents and full beneficiary details.

19th August 2022

THB: Thai Bhat

Full beneficiary address must be included in Field 59 and full remitter name and address must be included in Field 50.

26th August 2022

PYG: Paraguayan Guarani

Please contact your StoneX representative in advance if you are expecting increased flow in this currency.

2nd September 2022

AUD: Australian Dollar

Full beneficiary address must be included in Field 59 and full remitter name and address must be included in Field 50.

9th September 2022

UAH: Ukrainian Hryvnia

StoneX can support UAH payments again. All currency requirements remain the same.

22th SEPTEMBER 2022

PKR: Pakistani Rupee

4-character purpose of payment code is recommended for all PKR payments. List of codes are available upon request.

30th SEPTEMBER 2022

NAD: Namibian Dollar and ZAR: South African Rand

As per the existing local exchange control regulation a BOPCUS FORM needs to be completed for all NAD & ZAR payments.





15th November 2022

NAD: Namibian Dollar

For tax payments in NAD, the tax number is required in the payment instructions in field 70.

- 3. 10-digit code: consisting of a 2-digit code (according to relevant legal entity involved in transaction; code will indicate the tax office the entity is attached to) + 8-digit TIN Code (for Legal entity or Individual Entrepreneur) or Social card (for individual).
- Name of the customer.
- 3-digit bank codes are required to be added in front of the beneficiary account number (**Mandatory Field 59**). Please see the following page for a sample of codes. Please note that these codes are not exhaustive and may be subject to change.

- In-depth purpose of payment (Mandatory Field 70). If the payment is for charitable purposes, this must be clearly stated, or the beneficiary may be subject to a tax charge for income received.

- The beneficiary will be required to evidence the right to receive the funds before they can be settled.
- If the local beneficiary is a non-profit organization, approval by the local NGO bureau is required in order to receive funds.
- On value date, the local correspondent bank will inform the beneficiary bank of the payment. The beneficiary is then required to complete an Inward Remittance Form (Form C) indicating the purpose of the payment. After the correspondent bank receives the completed form, it will release the funds to the beneficiary bank to be credited to the beneficiary.
- The onshore correspondent bank or beneficiary bank may request supporting documents from the beneficiary to evidence the identity of the beneficiary and to confirm the purpose of the payment. If the beneficiary is an NGO, they will need to request approval prior to receiving funds for specific projects.
- STONEX cannot deliver BDT to convertible or non-convertible multiple currency BDT accounts.
- Local market is closed every Friday.

PAYMENT REQUIREMENT

For a beneficiary to successfully receive their BDT, they are first required to fill out a Form C. All payments into Bangladesh require the completion of a Form C regardless of amount.

PAYMENT PROCESS

- 1) On the value date, our paying bank will send a "Letter of Intimation" to the beneficiary bank.
- 2) Once the beneficiary bank receives the above letter, they will contact the beneficiary to complete the required Form C. If the beneficiary bank does not do this, the beneficiary may wish to contact the beneficiary bank directly to enquire about the incoming funds. PAYMENT PROCESS

- TWD utilises a slightly different settlement mechanism to the other currencies in terms of how STONEX covers trades.
- STONEX can only cover trades when we are in receipt of the payment instructions. STONEX can then only purchase the funds for spot value. It is not just the matter of receiving the trade and making the transfer as would be the case for all other currencies, hence, realistically, the delivery of TWD will always be at minimum, T+3.
- On value date, our local correspondent will send the remittance advice to the beneficiary bank, who is also responsible for informing the beneficiary to fill in the required paperwork.
- There are two types of documents:
- a) One for all transfers regardless of size and
- b) One for transfers greater than TWD 500,000.00
- For example, if the transfer is for TWD 500,001.00, the beneficiary will be required to complete two forms.
- Please note that the beneficiary bank may not always inform the beneficiary of the inbound transfer – this varies from bank to bank. They will also not always do so on the given value date; sometimes only after the payment is noted as outstanding or sometimes, not at all.
- Therefore, from our experience, we recommend that the remitter informs their beneficiary of the incoming transfer and for which value date so that the beneficiary can proactively contact their bank to complete and submit the relevant paperwork (with the onus being on them). Upon completion, the beneficiary bank can forward the documents to our bank, thereby releasing the funds. Unfortunately, we cannot control any delays in this process that occur between the beneficiary bank and the beneficiary.

This is only required for cross border payments related to services for social media content and payments for software development by individuals or corporates or equivalent. Such payments would involve a 1% advance Income Tax that our local correspondents will settle on behalf of the beneficiary to the tax authority.





24th SEPTEMBER 2021

AED: United Arab Emirates Dirham POP Code

All AED payments must include a 3-character purpose of payment code. List of codes are available upon request.

LYD: Libyan Dinar

2nd NOVEMBER 2021

NPR: Nepalese Rupee

9-digit Permanent Account Number (PAN) of the beneficiary required for cross border payments related to any consultancy services (software related or not) which would apply to individuals only. These payments would involve a 1% advance Income Tax that our local correspondents will settle on behalf of the beneficiary to the tax authority.

NOSCAGAG is no longer a valid Swift BIC code for Scotiabank Antigua. All payments processed to NOSCAGAG will be rejected.
